- # Daily cleaning of stand (Type A. once daily).
- # Minimum electricity consumption (0.13 kW/sq.m)
- # Assembly rights.
- # Lighting in the form of rows of 300 W halogen spotlights, one spotlight per 4 sq.m of stand.
- # Switchboard with magnetothermal differential and 500 W sockets, able to handle up to 130W/sq.m.
- # Stand sign in standard lettering bearing the exhibitor's name and the stand number. Maximum 20 characters.
- # Stand furniture (for every 16 sq.m booked):
 - 8 round table (90 x 74 cm),
 - 32 chairs, 8 stools.
 - 4 inclined product displays (maximum 4 units)
